- (i) in relation to PR Notes issued by (a) NAB or (b) BNZ, a supplement to the Offering Circular for the purposes of Article 23(1) of the Prospectus Regulation and has been approved as such by the *Commission de Surveillance du Secteur Financier* (the **CSSF**) as competent authority under the Prospectus Regulation; and
- (ii) in relation to Exempt Notes issued by (a) NAB or (b) BNZ, a supplement to the Offering Circular for the purposes of rule 206 of Part 2, Chapter 2 of the rules and regulations of the Luxembourg Stock Exchange and has been approved as such by the Luxembourg Stock Exchange as competent entity under Part IV of the Prospectus Act 2019.

This Supplement is prepared in connection with the Programme established by, *inter alios*, NAB and BNZ. Capitalised terms used but not otherwise defined in this Supplement shall have the meaning ascribed thereto in the Offering Circular. When used in this Supplement, **Prospectus Regulation** means Regulation (EU) 2017/1129 and **Prospectus Act 2019** means the Luxembourg act dated 16 July 2019 on prospectuses for securities.

This Supplement constitutes a supplement to, and should be read in conjunction with, the Offering Circular and all documents which are deemed to be incorporated therein by reference (see "Documents Incorporated by Reference" in the Offering Circular, as amended hereby).

On 3 February 2023, the sole shareholder of BNZ passed a special written resolution revoking the existing BNZ constitution and adopting the new BNZ constitution (the **New BNZ Constitution**). The New BNZ Constitution was adopted by BNZ with effect from 3 February 2023.

A copy of the New BNZ Constitution has been filed with the CSSF and the Luxembourg Stock Exchange and, by virtue of this Supplement, the New BNZ Constitution is incorporated by reference into, and forms part of, the Offering Circular, to the extent provided in section 3 of this Supplement below, and is available via <a href="https://dl.bourse.lu/dlp/1019723c2f599244618e2812cd38e39bb6">https://dl.bourse.lu/dlp/1019723c2f599244618e2812cd38e39bb6</a>. The previous constitution of BNZ is no longer considered by BNZ to be relevant for investors.
